In this workshop, Mr. Ip Ho Kin will use his expertise as family mediator to address the following issues related to divorce:

- 1. The legal requirements of establishing and dissolving a marital relationship in Hong Kong,
- 2. An overview of the procedures of divorce petition in Hong Kong,
- 3. Jurisdiction of the Hong Kong Family Court,
- 4. Essential matters between divorcing parties:
 - i. Matters related to any child who is involved in the marital relationship including custody and visitation as well as child maintenance,
 - ii. Distribution of family assets involved in the marital relationship, and
 - iii. Spousal maintenance.
- 5. Family mediation and divorce petition,
- 6. The intervention of Parenting Coordination.

About the Speaker

Mr. Ip Ho Kin is a practicing barrister whose scope of practice includes criminal, civil, and family matters. Mr. Ip is keen in tertiary education and has been appointed as adjunct assistant professor and part-time lecturer of the Hong Kong University, Chinese University of Hong Kong, City University of Hong Kong, Hong Kong Polytechnic University and Hang Seng University. Mr. Ip is also enthusiastic in public services. In addition to being appointed by the Development Bureau as a panel Chairman of Appeal Tribunal under s45 of the Buildings Ordinance, he also works as an honorary legal adviser and volunteer family mediator in many NGOs.
